#### B Technical Criteria of QR:

- 1. The applicant should be manufacturer of 400 kV or higher-class Current Transformer (CT)
- 2. The applicant should have supplied at least 15 (FIFTEEN) nos. of single-phase Current Transformers of 400 kV or above voltage class either directly or through package supplier within last 05 (FIVE) years from the date of application for enlistment.
- 3. Party should submit performance certificate for 400 KV CT from any of their client utilities to whom they have supplied & such certificate should not be more than 05 (FIVE) years old.
- 4. The applicant should have carried out type test of their 400 kV CTs as per relevant IS-2705/ IEC-61869-2 standard.
- 5. The vendor should have in-house testing facility (routine and acceptance tests) for CTs as per relevant standards.

# C Documents required in support of meeting Qualifying Requirements (QR):

- 1. QR-1: Documents in support of manufacturing facility: Valid ISO certificate/NSIC/UAM/ Registration/factory License/ any other suitable document as a proof of being manufacturer of the required material. Brief details of manufacturing facilities for CTs are also to be given.
- 2. QR-2: PO / Contract / Work order copies and their Invoices/completion Certificates etc. in support of supply and a tabular statement of same as per annexure-I.
- 3. QR-3: The performance certificate from any of their end user/ client utilities.
- 4. QR-4: The applicant should submit Type Test Certificate from accredited laboratory (accredited based on ISO/IEC Guide 25 / 17025 by the National accreditation body of the country), as per IEC /IS/technical specification. The type test reports should not be older than 07 (SEVEN) years as on the date of application.
- 5. QR-5: Self certification with details of testing facilities

#### D Other Documents to be submitted:

In addition to the documents required in support of meeting technical requirements as stated above, following documents are required to be submitted by the Applicants applying for enlistment:-

- 1. Three POs of the highest executed values of similar work (see definition at point E-Note below) during previous five years from the date of application. Copy of Invoice / Completion certificate from the concerned buyer/s in support of successful execution of supply against the POs to be submitted. These will be required for calculation of execution capability.
- 2. Audited balance sheet including Profit & Loss statement for the previous three completed financial years reckoned from the date of application. In case the audited documents are not ready / available, then certified copy by a registered practicing Chartered accountant may be submitted.
- 3. Latest annual report OR NSIC / SSI / MSME registration certificate / BIS license / ISO certificate / Certificate of registration from the concerned excise department / any other statutory document as a proof of being manufacturer of the required material.
- 4. Any other documents in addition to the above which the applicant wants to submit.
- 5. NTPC can ask other documents as necessary during the course of evaluation.
