Three POs with BOQ of the highest executed values of similar work during previous five years from the date of application and Copy of Completion Certificate /RA Bill/Final deviation statement from the concerned client in support of execution of job against each of the POs to be submitted. 2. Audited balance sheet including Profit & Loss statement for the previous three completed financial years reckoned from the date of application. In case the audited documents are not ready / available, then certified copy by a registered practicing Chartered accountant may be submitted. 3. NSIC / SSI / MSME registration certificate, if applicable 4. PF and Service Tax registration certificate 5. Any other documents in addition to the above which the applicant wants to submit. 6. List of all required Tools & Plants with populations available with the applicant.
