Three POs with BOQ of the highest executed values of similar work during previous five years from the date of application and Copy of Completion Certificate /RA Bill/final deviation statement from the concerned client in support of successful execution of works against each of the POs to be submitted.</li> <li>2. Audited balance sheet including Profit &amp; Loss statement for the previous three completed financial years reckoned from the date of application. In case the audited documents are not ready / available, then certified copy by a registered practicing Chartered accountant may be submitted.</li> <li>3. NSIC / SSI / MSME registration certificate if applicable</li> <li>4. PF and Service Tax registration certificate</li> <li>5. Any other documents in addition to the above which the applicant wants to submit.</li> <li>6. List of all required Tools &amp; Plants with populations available with the applicant.</li> </ol>
