4	Brief scope of work	<p>HP Jet Cleaning of Boiler Heating Surfaces and APH Baskets:</p> <ol style="list-style-type: none"> 1. This Brief Scope of Work is indicative only. The detailed Scope of Works shall be as mentioned in tender enquiry by respective sites. 2. HP Jet cleaning of boiler passes: <ol style="list-style-type: none"> (i) Cleaning of Boiler internal /heat transfer surfaces and air heater baskets with high pressure water jet during period mentioned in tender enquiry. ii) The scope of work includes to and fro transportation of sufficient numbers (as mentioned in enquiry) of H.P. jet pumps with accessories from vendor's site to respective boilers. No separate payment will be done on this account. Party shall have to mobilize the pumps well in advance from the commencement of work (as intimated by NTPC). iii) The total area of all four sides of water walls, Roof tubes, Platen super heater, Division panels, Goose neck, Reheater coils and any other boiler internal surfaces as required. iv) Scaffolding/sky climber will be provided by NTPC for accessing the areas to be cleaned. Sufficient parallel gangs have to be provided for cleaning the boiler round the clock in pump hours mentioned in tender enquiry. On completion of cleaning, contractor shall offer the area for inspection and get certified by EIC/Area Engineer. Failure to clean all the areas in the specified time will attract penalty as mentioned in tender enquiry. 3. HP Jet cleaning of APH baskets: <p>The scope of work includes to and fro transportation of sufficient numbers (as mentioned in enquiry) of H.P. jet pumps with accessories from vendor's site to respective locations. No separate payment will be done on this account. Party shall have to mobilize the pumps well in advance from the commencement of work (as intimated by NTPC).Cleaning of Air Pre-heater basket shall cover:</p> <ol style="list-style-type: none"> (i) Transportation of pump and accessories at air heater floor or area where baskets are to be cleaned. (ii) Cleaning of all the baskets (the numbers as mentioned in tender enquiry) within pump hours mentioned in tender enquiry. (iii) For above contractor shall deploy sufficient parallel gangs to carry out the cleaning work. Cleaning shall be certified by area engineer. Failure of proper cleaning work within stipulated time frame shall attract penalty as mentioned in tender enquiry. 4. HP Jet cleaning of Mill APH baskets: <p>This enlistment may be used for cleaning of mill APH baskets as in stations like Rihand etc as per details mentioned in tender enquiry.</p> <p>Note- The vendor must have at least Two nos. of Trolley mounted and 04 nos. of portable HP jet cleaning machines.</p>

Audited balance sheet including Profit & Loss statement for the previous three completed financial years reckoned from the date of application. In case, the audited documents are not ready/ available, then certified copy of financial statement by a registered practicing chartered accountant may be submitted. iii. NSIC / SSI / MSME registration certificate iv. PF and GST/Service Tax registration certificate v. Any other documents in addition to the above which the applicant wants to submit.
