Additional Documents to be submitted	<p>In addition to the documents required in support of meeting technical requirements as stated above, following documents are required to be submitted by the Applicants applying for enlistment:-</p> <ol style="list-style-type: none"> 1. Three POs with BOQ of the highest executed values of similar work during previous five years from the date of application and Copy of Completion Certificate /RA Bill/ final deviation statement from the concerned client in support of successful execution of jobs against each of the POs to be submitted. 2. Audited balance sheet including Profit & Loss statement for the previous three completed financial years reckoned from the date of application. In case the audited documents are not ready / available, then certified copy by a registered practicing Chartered accountant may be submitted. 3. NSIC / SSI / MSE registration certificate, if applicable. 4. PF and Service Tax registration certificate. 5. Any other documents in addition to the above which the applicant wants to submit.

Similar work means: Inspection and Rectification / Erection of Coal Bunkers.</p> <p style="text-align: center;">OR</p> <p>Erection or Overhauling jobs of Ducts/ Dampers/ Gates /Air Preheater (APH)/Boiler pressure parts in Thermal Power plant of unit capacity of minimum 60MW.</p> <p>In case of any composite PO which includes Inspection and Rectification / Erection of Coal Bunkers or erection of boilers/structures up to a minimum height of 30 metres in addition to other mechanical maintenance / overhauling /erection jobs in any Industry, the overall executed value of the PO excluding material supply, if any, shall be considered as executed value for calculation of EC.</p> <p>Remarks:</p> <ol style="list-style-type: none"> (i) Full executed value of Composite POs considered since it is not possible to calculate value of job carried out for only erection or maintenance of coal bunkers and associated jobs in absence of BOQ (Lumpsum Contracts). (ii) Additionally similar work criteria broadened by including works at height like pressure parts job/biller or structure erection and the height considered is 30 metres which is approximately average height of bunkers in standard 200 MW boiler.
