<b>5.2</b>	<b>Document to be submitted by Vendor in support of meeting QR</b>	The bidder shall submit Three POs with BOQ of the highest executed values of similar work during previous five years, as on last date of the month preceding the month of publication of NIA and Copy of Completion Certificate /RA Bill/Final Deviation Statement from the concerned client in support of successful execution of work against each of the POs to be submitted.
<b>5.3</b>	<b>Note Applicable to clause 5.1 (Technical Criteria):</b>	<b>i)</b> The word “executed” means the bidder should have achieved the criteria specified at clause no 5.1 and 5.2 of QR, even if the total order is not completed/closed. In case any order is under execution as on last date of the month preceding the month of publication of NIT, the value of supply executed against such order till such date will be considered provided the same is certified by the Owner/ Project Authority. <b>ii)</b> Reference work executed by a Bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by the Owner/Project Authority specifying the scope of work executed by the sub-contractor in support of Qualifying
