5.3	Note Applicable to clause 5.1 (Technical Criteria):	<p>i) The word "executed" means the bidder should have achieved the criteria specified at clause no 5.1 and 5.2 of QR, even if the total order is not completed/closed. In case any order is under execution as on last date of the month preceding the month of publication of NIT, the value of supply executed against such order till such date will be considered provided the same is certified by the Owner/ Project Authority.</p> <p>ii) Reference work executed by a Bidder as a sub-contractor may also be considered provided the certificate issued by main contractor is duly certified by the Owner/Project Authority specifying the scope of work executed by the sub-contractor in support of Qualifying Requirements</p> <p>iii) In case of composite work/BOQ, the bidder shall have to furnish Certificate from Owner/Project Authority certifying the value of specific nature of work, as mentioned in clause 5.1</p> <p>iv) Value means basic value of the PO. Where PO value is composite (i.e. including Service taxes etc.), the applicant has to give break up of composite PO value mentioning basic value, taxes etc</p>
