3.2	<p>The Bidder should be an integrated steel producer which means that the Bidder should be a Primary Steel Producer, having a minimum capacity of one million tonnes per annum (mtpa) in terms of crude Steel.</p> <p>NOTE: THE "Primary Steel Producer" shall mean Steel Producer of any capacity, irrespective of process route, starting their operations from iron making using iron ore, virgin or processed, with necessary refining facilities and rolling/processing facilities, at a single location or else in multiple locations provided that the entire gamut of iron & steel production, from iron making to finished steel production, is owned by the same company or its subsidiary company(ies). Provided that the iron making capacity is sufficiently matching the steelmaking capacity of one million tonnes per annum (mtpa). Further, downstream units should use material from the upstream units of the same company or its subsidiaries.</p>	
3.3	<p>The average annual turnover of the bidder in the preceding three (3) financial years as on the date of submission of application for enlistment shall not be less than Rs. 1000.00 Crore [Rupees One Thousand Crore].</p> <ol style="list-style-type: none"> 1. In cases where audited results for the last financial year as on the date of submission of application for enlistment are not available, the financial results certified by a practicing Chartered Accountant shall be considered acceptable. In case, Bidder is not able to submit the Certificate from a practicing Chartered Accountant certifying its financial parameters, the audited results of three consecutive financial years preceding the last financial year shall be considered for evaluating the financial parameters. Further, a certificate would be required from the CEO/CFO as per the format enclosed in the bidding documents stating that the Financial results of the Company are under audit as on the date of submission of application for enlistment and the Certificate from the
